



Regional Connector Transit Corridor

The Los Angeles County Metropolitan Transportation Authority (LACMTA) issued RFP No. C0980 requesting Proposals for the Regional Connector Transit Corridor Project - Design/Build. The work under this contract will include, but is not limited to, furnishing all management, coordination, professional services, labor, equipment, materials and other services to perform the final design and construction of the Project for 1.86 miles of light rail that will link the current terminus of the Blue and Expo Lines at 7th/Metro Center to the Gold Line near the little Tokyo/Arts District Station in a new underground alignment along Flower Street and Second Street in Downtown Los Angeles.

The issued RFP is the second phase of a two step process for a “Best Value Procurement”. The following design builders have been pre-qualified to submit a proposal:

- Dragados / Schiavone / Southland, a Joint Venture (Dragados USA, Inc., Schiavone Construction Co. LLC, and Southland Contracting, Inc.)
- Regional Connector Constructors (Skanska USA Civil West California District, Inc., Kiewit Infrastructure West Co.; and Traylor Bros., Inc.)
- Shea / Walsh / PTG Joint Venture (J. F. Shea Construction, Inc., Walsh Construction Company, and Parsons Transportation Group, Inc. (PTG))
- Shimmick / Obayashi / FCC, a Joint Venture (Shimmick Construction Company, Inc., Obayashi Corporation, and FCC Construcción, SA)

A Pre-Proposal Conference will be held on **February 5, 2013**, at 9:30 a.m. in the Board Room on the 3rd Floor of the Metro Gateway Plaza Building. Attendance at the Pre-proposal Conference is not mandatory but is highly recommended for each pre-qualified team. **(Note that LACMTA does not pay for parking or validate tickets.)**

The RFP package is not available for review or download from LACMTA’s website. A complete set of the RFP package is available on DVDs. Each DVD package can be purchased for a price of \$25.00 when picked up at Los Angeles County Metropolitan Transportation Authority (Metro), One Gateway Plaza, Los Angeles, CA 90012-2952, 9th Floor Receptionist or \$50.00 if the DVD package is to be mailed. Requests must be accompanied by payment to LACMTA in the form of a money order, a company check, a cashier’s check, or a certified check (personal checks are not an acceptable form of payment); Monday through Friday (except holidays) between the hours of 9:00 a.m. and 4:00 p.m. at the Metro Gateway Plaza building at the address above.
