Mr. Banash also complained about increasing Blue Line delays to single tracking. CAC members agreed to agendize Blue Line update at the July CAC Executive Committee meeting and consider at that meeting whether there is a need to schedule Blue Line Operations and Reliability at a future GA meeting.
